3. National Anthem



- 1. Graduation Coaches for Black Students Sharise Sealy-McCallum and Marlo Paraboo
  - Program objective to provide intensive, culturally responsive support to Black students to improve wellbeing and academic achievement
  - Academic achievement flourishes when students are represented and understood, and there is advocacy for students when they do not feel these things
  - Long term outcomes for Black student success include identification of systemic barriers and inequalities in the education system, transformation of school culture by educators who have collective knowledge, skills, and dispositions to understand and respond effectively to the learning needs of every student. Establish trusting relationship with Black students, families, and communities
  - Common themes students have expressed- barriers in classrooms and expectations students will not behave, expectations being lowered academically and streaming of students, lack of representation in schools re: books, posters, staff, and racism and micro aggressions- teachers touching students' hair, comments from staff they are surprised at student achievement

#### SUBJECT: MPAC School Support Modernization Project

As you know, OCSTA has been meeting with MPAC on its School Support Modernization Project. The purpose of this project is to improve the operational school support data collection process related to property tax designation.

On Thursday August 4, MPAC met for the second time with OCSTA, other trustee/board associations and boards, to provide an update on the development of the modernization project. (We have attached the presentation material for your review). The meeting included a demonstration of the digital tools being developed and a discussion about digital tool, and how MPAC can improve the data collection process facing school boards. The demonstration of the tool can be viewed at (https://www.youtube.com/watch?v=IEtfJXTMWdI).

The attached material also includes a detailed timeline and deliverables for the modernization project.

#### Next Steps:

MPAC is asking boards to complete the attached survey <u>https://forms.office.com/r/McKWcL5cZJ</u>) on the digital tool and to collect feedback on board experiences regarding the school support information collection process. MPAC will then meet with trustee associations and school boards in the Fall to discuss details related to the roll-out of the digital tool.

OCSTA would appreciate it if boards could send us any feedback on this project and the data collection process so we can forward these concerns to MPAC.

I would like to commend the representatives from Catholic school boards (Assessment Department Officials and others) who have been attending these meetings. Their input and wise counsel has been extremely helpful. I would as well like to recognize OCSTA Director of Legislative and Political Affairs, Stephen Andrews, for his tireless work regarding this important matter.
